Introduction

Under statutory legislation PCT's have a requirement to have in place a robust procedure for managing clinical requests for individual procedures outside the core delivered NHS services. These requests are known as Individual Funding Requests (IFR).

Background

A Yorkshire and Humber wide policy was adopted in January 2010 in response to the legal duties set out in the NHS constitution and Secretary of State's Directions to PCTs and Trusts. The key legal requirements are highlighted below:

- The NHS Constitution (January 2009): two rights relate specifically to the availability of medicines and other treatments
 - You have the right to drugs and treatments that have been recommended by NICE for use in the NHS, if your doctor/registered health practitioner says they are clinically appropriate for you.
 - You have the right to expect local decisions on funding of other drugs and treatments to be made rationally following a proper consideration of the evidence. If the local NHS decides not to fund a drug or treatment you and your doctor/registered health practitioner feel would be right for you, they will explain that decision to you.
- Directions to Primary Care Trusts and NHS Trusts concerning decisions about drugs and other treatment 2009 (Secretary of State, 12 March 2009), which set out primary care responsibilities on funding and commissioning health care interventions, and the duty to give reasons for decisions.
- Guiding principles for processes supporting local decision-making about medicines and a Handbook of Good Practice Guidance (Department of Health 2009).

An Individual Funding Request is appropriate where either the following applies:

- NHS Rotherham has a general policy not to fund a health care intervention for the specified indication but a doctor considers his/her patient to be 'exceptional' to that policy OR
- NHS Rotherham has no policy for the requested health care intervention and indication and the clinical circumstance is so rare that it is unlikely that any other patients will require the intervention.

This report reflects all requests received by the Individual Funding Request Panel Manager during the financial year 2011/12.

Pathway and Process

Triage

- · Receives requests from providers.
- Assesses requests against existing policies and for completeness.
- Informs provider of approve or decline according to policy criteria.
- Requests further information to assist decision making.
- Forwards requests to Individual Funding Request Panel if exceptionality is indicated.

Individual Funding Request Panel

- Receives Individual Funding Requests from Triage.
- Funding decisions made and communicated to provider and patient.

Appeals Panel

- Receives case for appeal on paper.
- Provides procedural review.
- Decision of the Panel communicated to the PCT, the patient, and the provider.

Analysis of Requests

From April 11 to March 12 the Individual Funding Request Panel has received 267 requests. Of these 181 decisions were made at Triage by the IFR Manager, 78 approved, and 103 declined. A further 86 were forwarded to the Individual Funding Request Panel, 38 approved, 48 declined. There have been 151 requests approved at an approximate cost of £1,224,872. (See attached). More than half (161) of the requests received are Plastic Surgery referrals of which just over a third (65) have been approved. This is consistent with previous years. However these figures indicate that there is still a need to raise awareness of the Specialist Plastic Policy to reduce the number of inappropriate requests received by Individual Funding Request Panel.

The increase in home Total Parental Nutrition (TPN) from one (2011/12) to six this year is reflected in the increased costs recorded for drugs. However from the new financial year this will be recorded elsewhere as it is now the responsibility of the Specialised Commissioning Services.

Appeals

There have been no appeals against decisions made at the Individual Funding Request Panel during this financial year.
