• Sections 3.1 – Text removed regarding practices to confirm in writing to the discharging hospital they have taken the responsibility for individual patient care.

This has not been part of the pathway for a number of years but the specification has just been updated to reflect this. The feedback from the LMC in relation to the removal of this text is that they cannot endorse it as it doesn't follow current BMA guidance. They have advised that their perception is that in removing this text the responsibility for any incidents of patient transfer being missed by general practice would sit with the CCG.

This has been flagged with the Medicines Management Team, but the CCG disputes that there would be any responsibility on their part.

Risks identified

Under NHS England and NHS Improvement's 'Investment and Evolution: A five-year framework for GP contract reform to implement The NHS Long Term Plan' programme, five new national specifications were due to be implemented from April 2020.

However, two of these have been delayed until 2022/23 – Personalised Care and Anticipatory Care. The new Anticipatory Care specification may duplicate some or all elements of the current Case Management LES. NHS England and NHS Improvement ordinarily release guidance prior to the services being introduced but as of December 2021, this guidance is not yet available for review.

In the meantime, the CCG proposes to continue to commission the current LES until further guidance has been received, to enable the CCG to determine what, if any, duplication exists. Once available, the Case Management LES will be reviewed against the national criteria and a decision will be taken with regards to the LES' future service delivery requirements.
