Background:

NHS Rotherham CCG works in conjunction with the Local Medical Committee (LMC), Local Pharmacy Committee (LPC) and Local Optical Committee (LOC) around changes in relation to re-commissioning the LES specifications. Those changes are then ultimately approved by the Primary Care Committee.

At the 10 February 2021 PCC meeting 12 GP Local Enhanced Service specifications, two Pharmacy Local Enhanced Service specifications and two Optometry Local Enhanced Service specifications were reviewed and approved.

Three specifications remained under review:

homes that are brought into operation but have not previously been funded under this scheme' and 'Respite homes - due to the nature of service provision within respite homes, these homes will be excluded from this LES. Practices aligned with respite homes will remain eligible for reimbursement in line with the national Enhanced Health in Care Homes DES.'

- Page 5 Section 4.1 Unplanned admissions review period changed from 2 to 3 months
- Page 5 Section 4.2 Remunerations removal of initial calculations and addition of: 'As practices are unable to fulfil the requirements of the LES within respite homes, due to the nature of the service provided by these facilities, respite homes will be reimbursed with line with the national Enhanced Health in Care Homes DES.
